

USER AGREEMENT of website adiltas.kz

№1 from 08.08.2023 г.

1 General Provisions

This User Agreement (hereinafter - "Agreement") applies to the https://adiltas.kz/ website (hereinafter - "Website") owned by Legal partners group "ADILTAS" and located at https://adiltas.kz/.

The Agreement regulates the relations between the Administration of the Website https://adiltas.kz/ (hereinafter - the "Website Administration") and the User of this site.

The Website Administration reserves the right to change, add or delete clauses of this Agreement at any time without notice to the User.

Continued use of the Website by the User means acceptance of the Agreement and changes made to this Agreement.

2 Subject of the agreement

The subject of the Agreement is to provide the Website User with access to the LPG "ADILTAS" services contained on the Website.

By accessing the Website, the User shall be deemed to have acceded to this Agreement.

The use of materials and services of the Website is governed by the norms of the current legislation of the Republic of Kazakhstan.

3 Rights of the Parties

The administration of the Website has the right:

- to change the rules of using the Website, as well as to change the content of this Website. Changes come into force from the moment of publication of the new edition of the Agreement on the Website.
- restrict access to the Website in case of violation of the terms of this Agreement by the User.

The User has the right:

- purchase any services offered on the Website.
- ask any questions related to the services written about on the Website.
- to use the Website exclusively for the purposes and in the manner provided by the Agreement and not prohibited by the legislation of the Republic of Kazakhstan.

4 Obligations of the User

Do not use the Website services for the purpose of downloading content that is illegal and violates any rights of third parties.



Do not take actions that may be considered disruptive to the normal operation of the Website.



Do not use the Website to distribute information of an advertising nature, otherwise than with the consent of the Website Administration.



Observe the property and nonproperty rights of authors and other right holders when using the Website.



In case of breach of this condition, User must pay to "LPG ADILTAS" compensation in the amount of 1,000,000 tenge or 2500 dollars.



Do not act to compare services, or to form negative attitudes towards or judge persons (not) using certain services.

5 The user is prohibited from:

- Use any devices, programmes, procedures, algorithms and methods,
 automatic devices or equivalent manual processes to access, acquire,
 copy or monitor the content of the Website.
- Disrupt the proper functioning of the Website.
- Violate the security or authentication system on the Website or any network related to the Website.
- Unauthorised access to the features of the Website, any other systems or networks relating to this Website and any services offered on the Website.
- To reverse look up, track or attempt to track any information about any other User of the Website.
- Copy, publish, reproduce, transmit or distribute the Website content by
 any means, as well as post on the global Internet without the prior written consent of the Website Administration.

6 Breach of the terms and conditions of the Agreement

The Website Administration has the right to disclose information about the User in cases:


- to fulfil the provisions of legislation or court decisions.
- to ensure the fulfilment of the terms and conditions of this Agreement.
- to protect the rights or safety of LPG "ADILTAS" and Users.

The Website Administration has the right to block access to the User in cases:

- if the User has violated this Agreement or the terms of use of the Website contained in other documents.
- in case of termination of the Website or due to a technical failure or problem.

7 Dispute Resolution

The parties to the Agreement shall follow the following procedure in the event of a dispute:



8 Additional terms and conditions

The Agreement is available in three languages:

- Russian
- Kazakh
- English

In case of disagreement in translations, the Russian text shall prevail.

Glossary

Website - a set of graphic and informational materials, as well as computer programmes and databases, ensuring their availability on the Internet at the network address https://adiltas.kz/.

User - any visitor to the adiltas.kz website.

Website Administration - authorised employees for managing the Website, acting on behalf of LPG "ADILTAS".

Website content - the protected results of intellectual activity, including texts, articles, illustrations, covers, graphic, textual, photographic, derivative, composite and other materials, user interfaces, visual interfaces, names, logos, computer programs, databases, as well as the design, structure, selection, general coordination, appearance, style arrangement of this content forming part of the website and other intellectual property objects all together and/or individually contained on the Website.

Based on the Law of the Republic of Kazakhstan dated 10 July 2023 No. 18-VIII "On online platforms and online advertising" and the Law of the Republic of Kazakhstan dated 21 May 2013 No. 94-V "On personal data and their protection".
